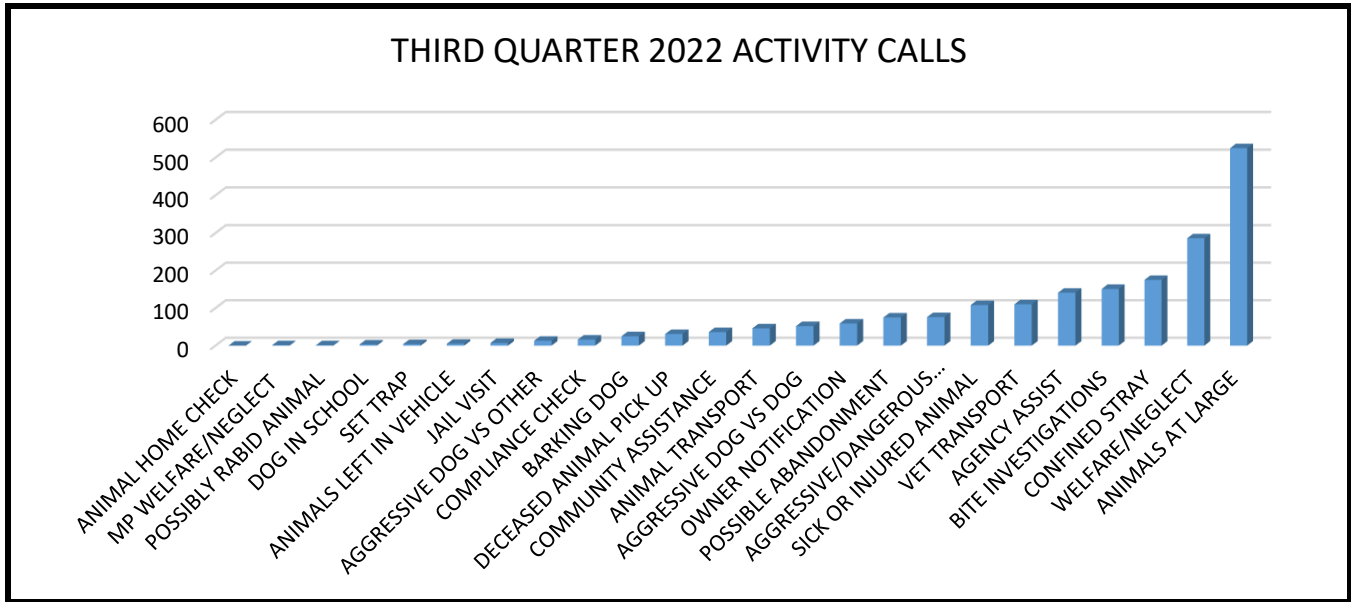
Field and Shelter Activity

FIELD SERVICES

Montgomery County Animal Care and Control provided active and on call animal control service for all areas of Montgomery County and the City of Clarksville for the Third Quarter of 2022.

Officer Activity

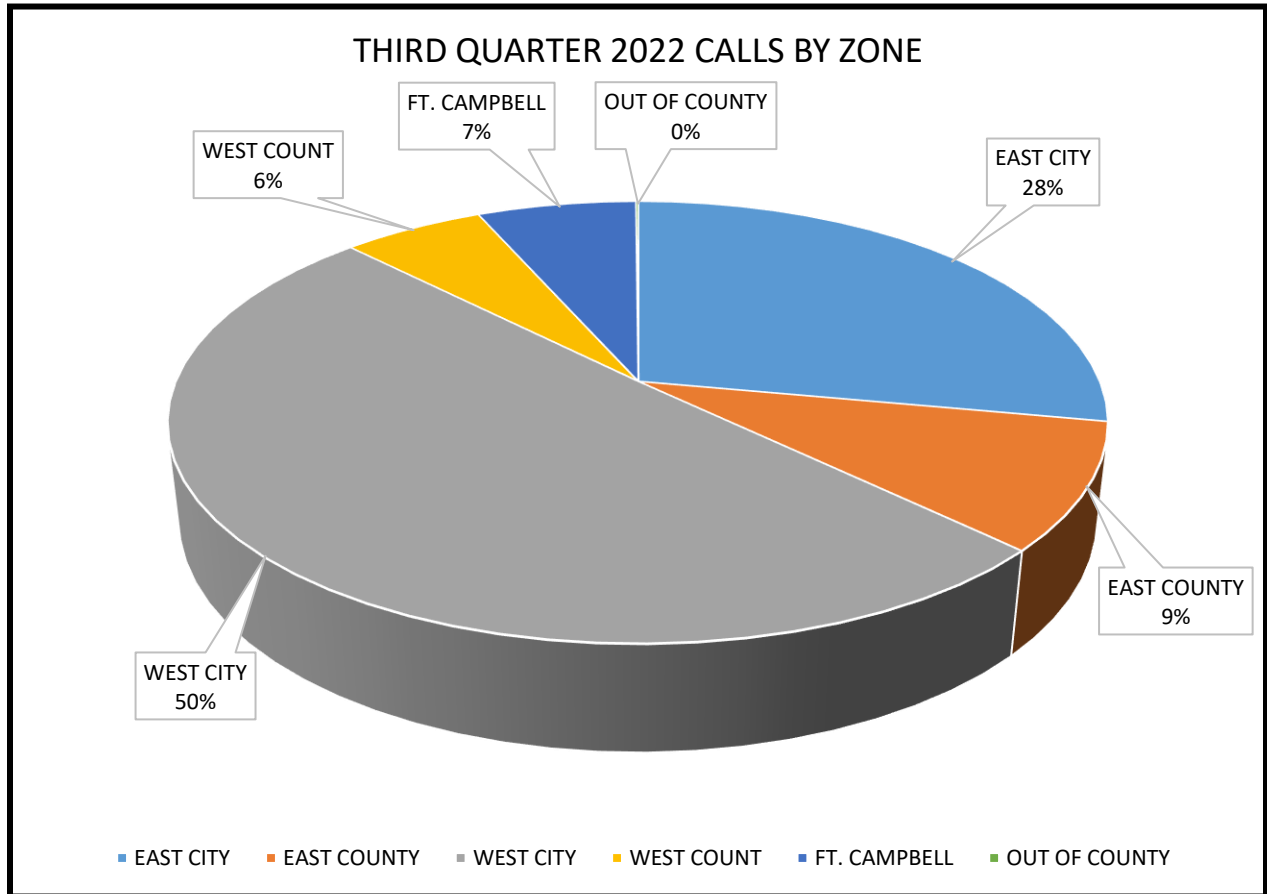
For the Third Quarter of 2022, Animal Control Officers handled 1,946 calls for service. This is a 29% increase over 2021. Well over a quarter of all calls, (27%) were for Stray Animals, normally a dog running at large. Investigations for Welfare/Neglect, Bites, Confined Stray's, Aggressive dogs made up for (36%) of all calls.

FIELD SERVICE CALLS BY ZONES

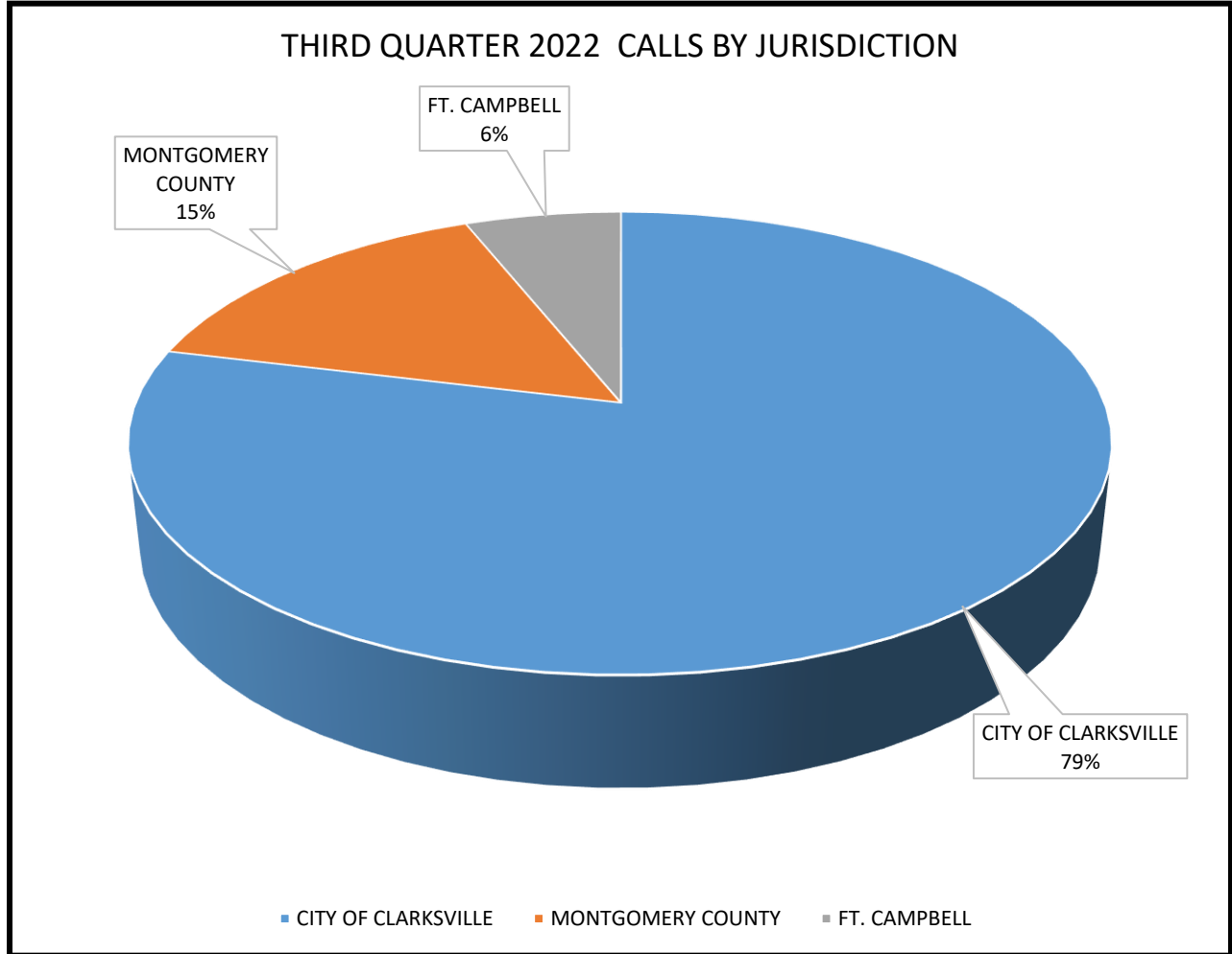

FIELD SERVICE CALLS BY JURISDICTION

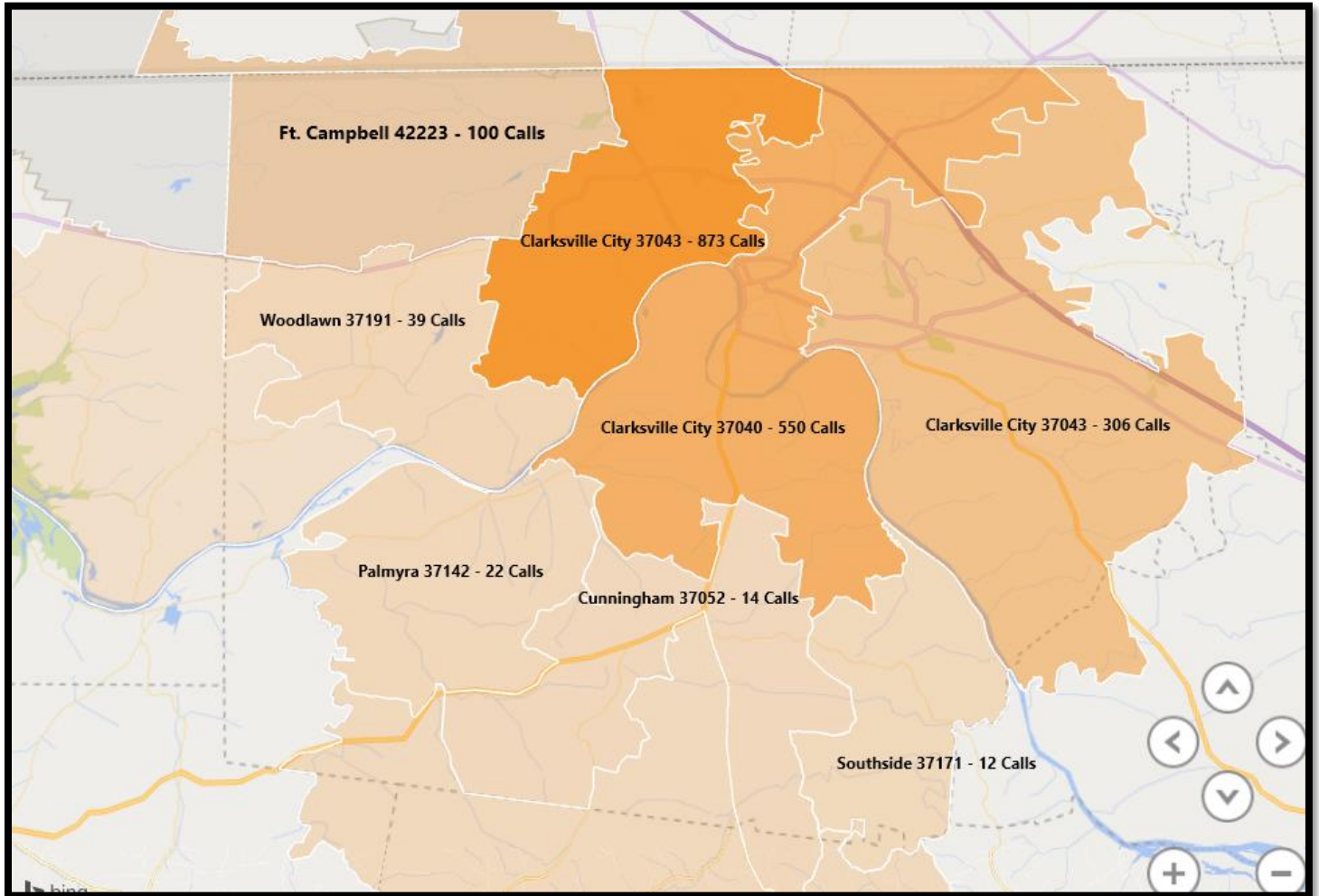
1,946 Calls for service that were responded to in Montgomery County were dispersed into the following two Jurisdictions, which covers the Montgomery County outside of the Clarksville City Limits and all unincorporated areas of the County, and within the city limits of Clarksville. (79%) of all calls for the Third Quarter of 2022 occurred within the City of Clarksville and (15%) of calls for the Third Quarter of 2022 occurred in the unincorporated areas of Montgomery County and 6% of all calls were in Ft. Campbell Military Base.

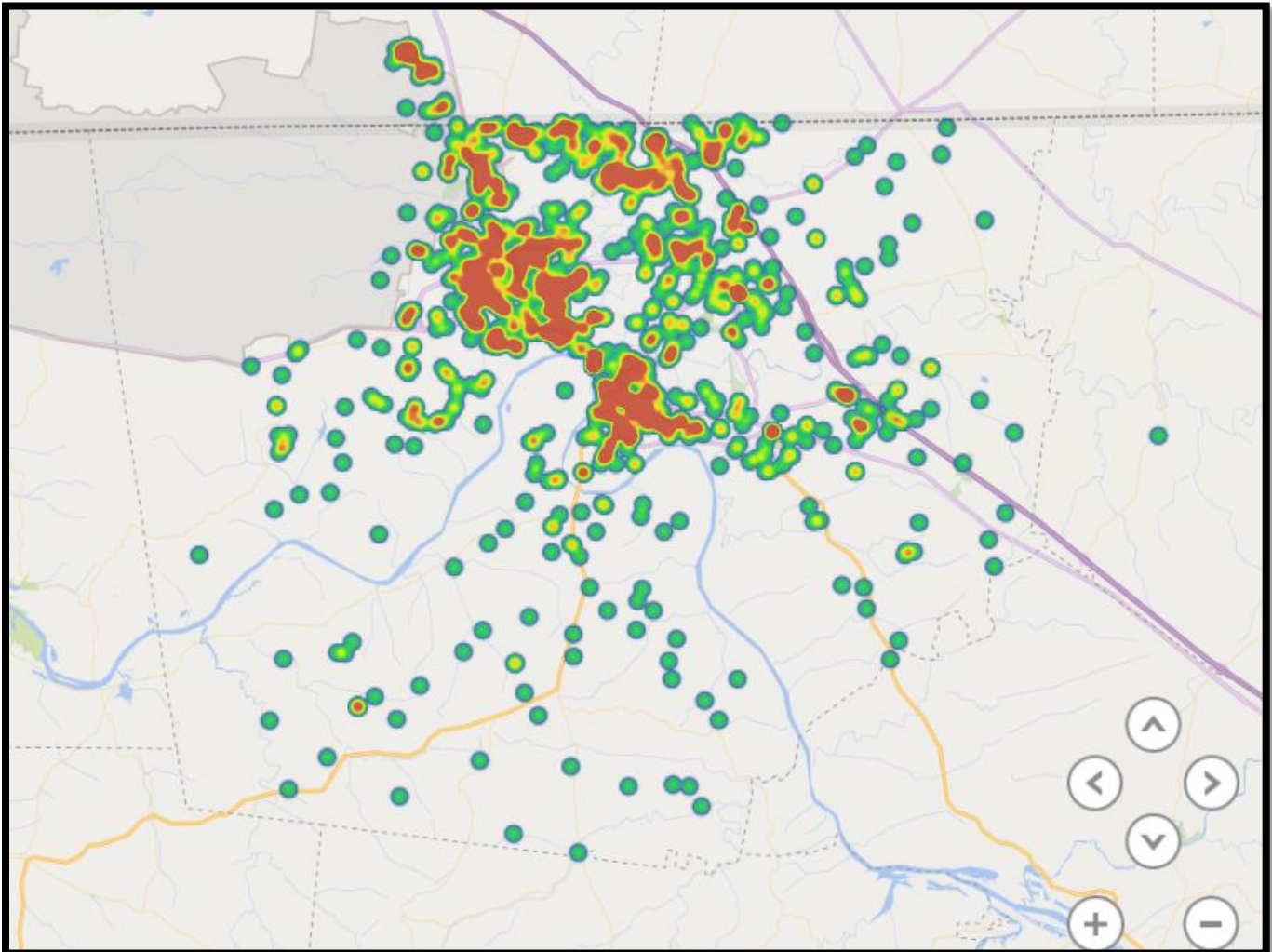
FIELD SERVICE CALLS HEAT MAP

Calls for service that were responded to in Montgomery County were dispersed into the following Eleven (11) Zip Codes, which covers the Montgomery County outside of the Clarksville City Limits and all unincorporated areas of the County, and within the city limits of Clarksville. (44%) of all calls for the Third Quarter of 2022 occurred within the 37042 Zip Code, which compromises the North Central portion of Montgomery County north of the Cumberland River, while (30%) of calls occurred in Zip Code area 37040, which compromises the Northeast and South Central portion of the County



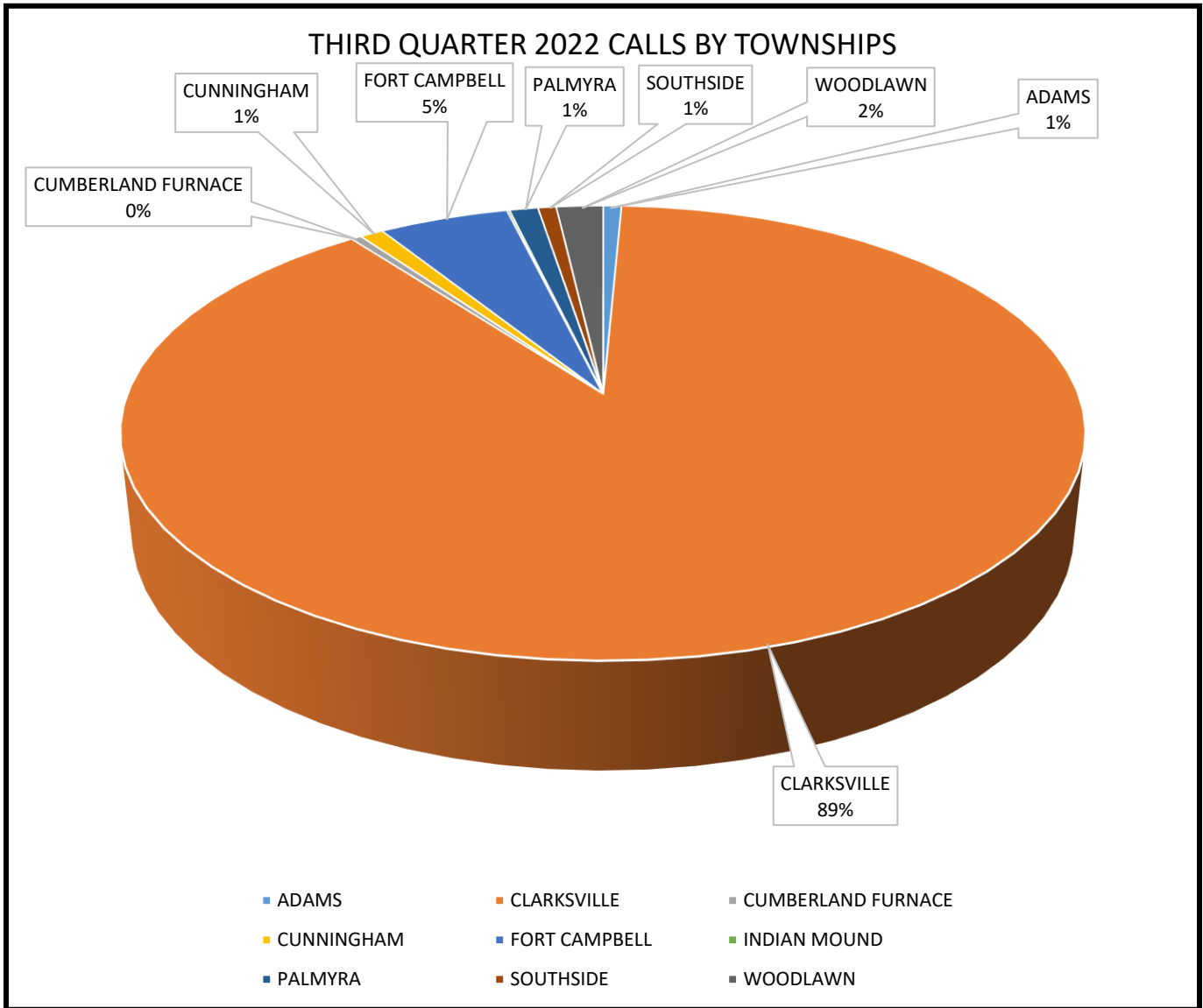
FIELD SERVICE CALLS HEAT MAP

OFFICER FIELD ACTIVITY RESULTS BY TOWNSHIP

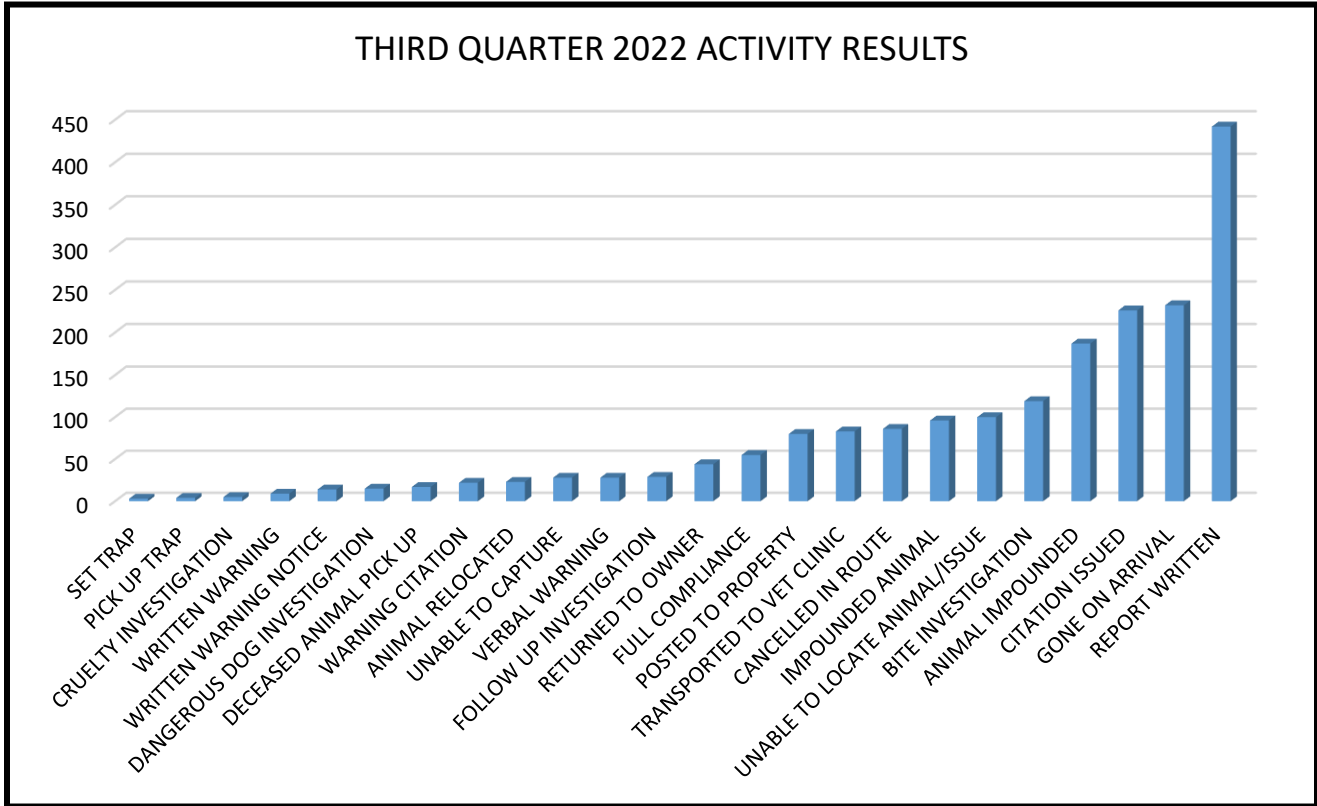
MCACC Officers responded to 1,946 Activity Calls in 12 different townships across Montgomery County. 89% Of Activity calls were within the City of Clarksville.

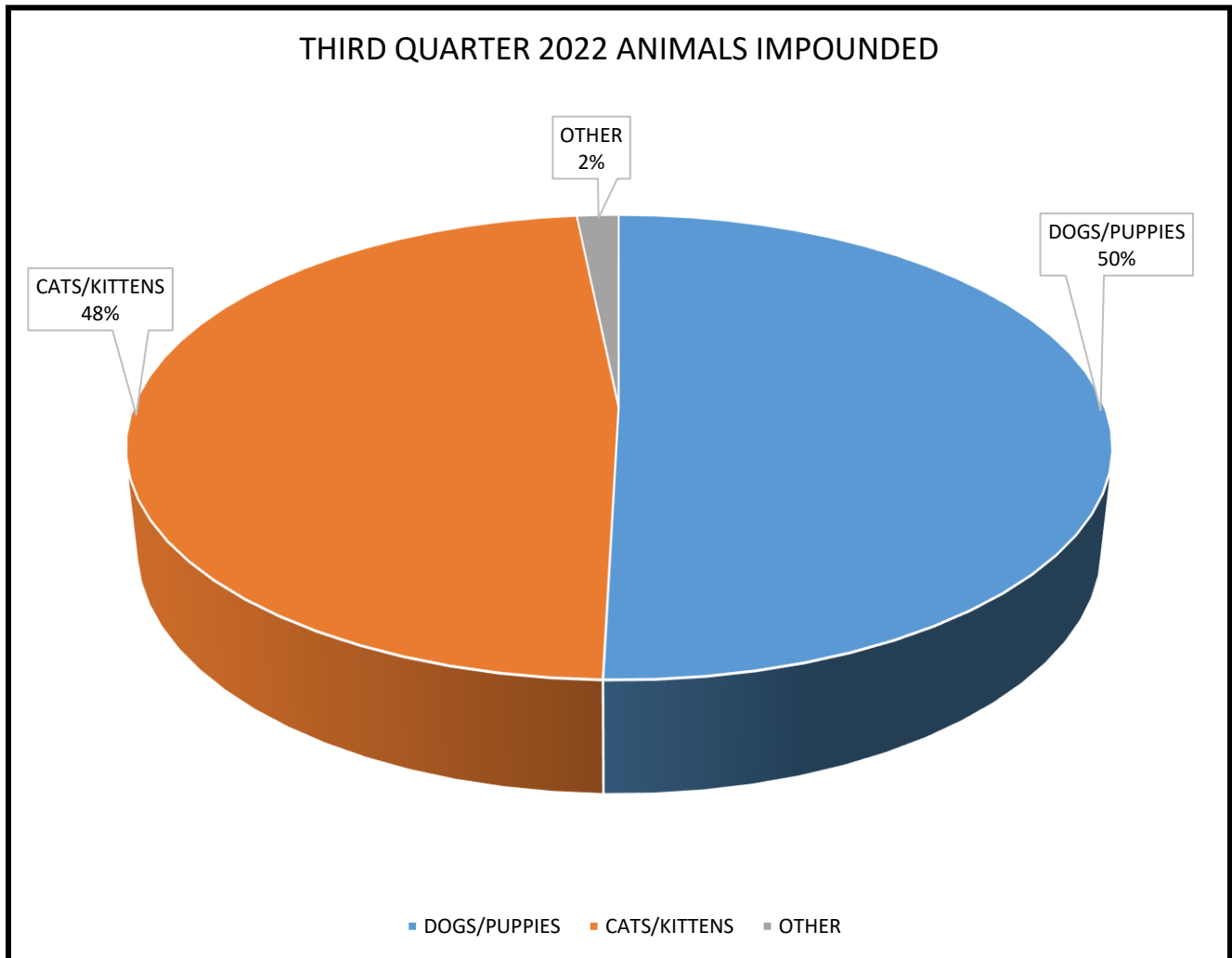
SHELTER AND ADOPTION SERVICES

Kennel Visitors

The shelter saw 4,547 visitors come through our doors for the Third Quarter of 2022, a 12% increase over the First Quarter. 85% of those visitors were looking to adopt a shelter pet while 15% came to the shelter to reclaim or look for a lost pet.

Animals Impounded

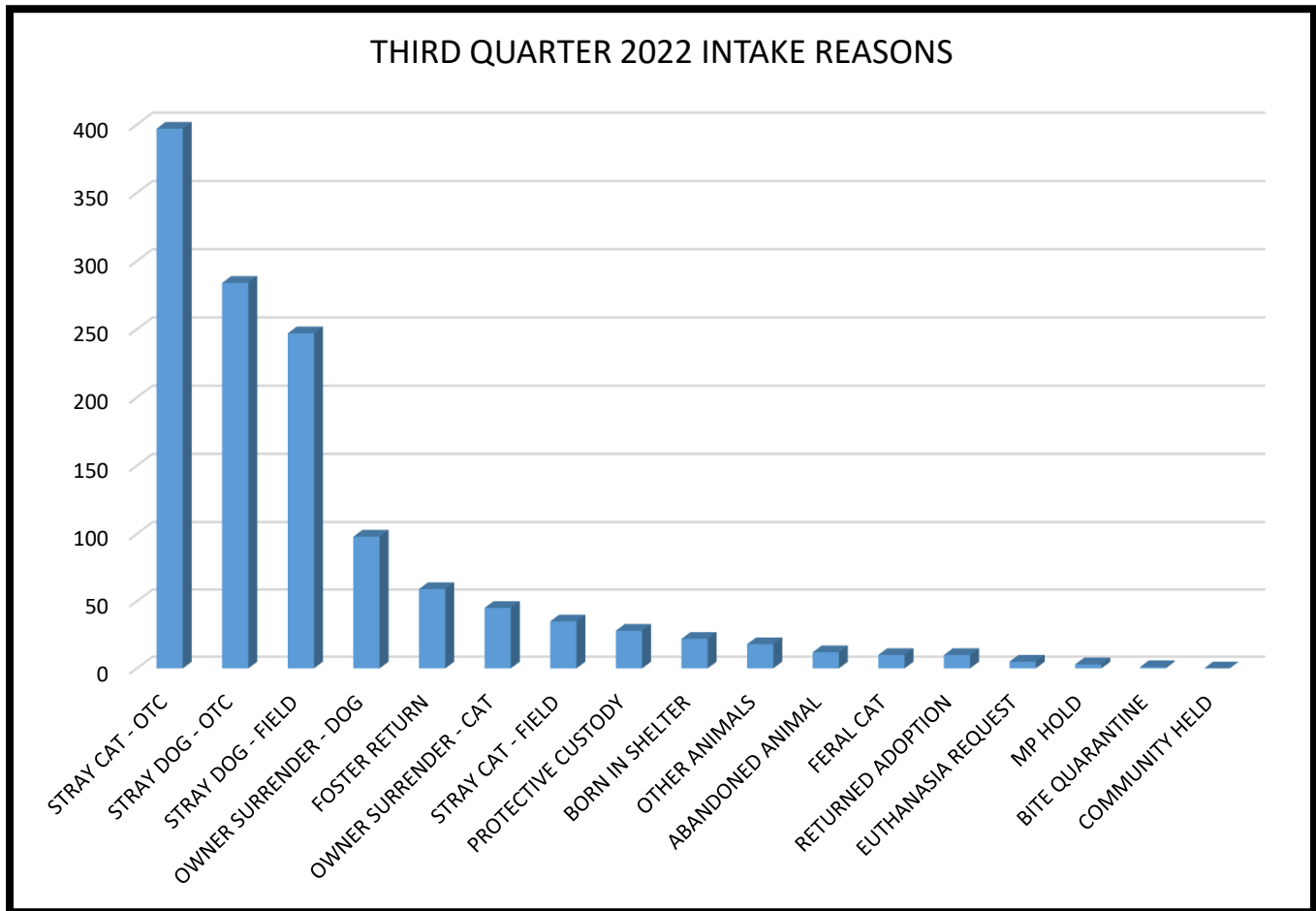
In the Third Quarter of 2022, 1,276 animals were impounded. Of the animals impounded, 48% were cats/kittens, 50% were dogs/puppies.

SHELTER INTAKE REASONS

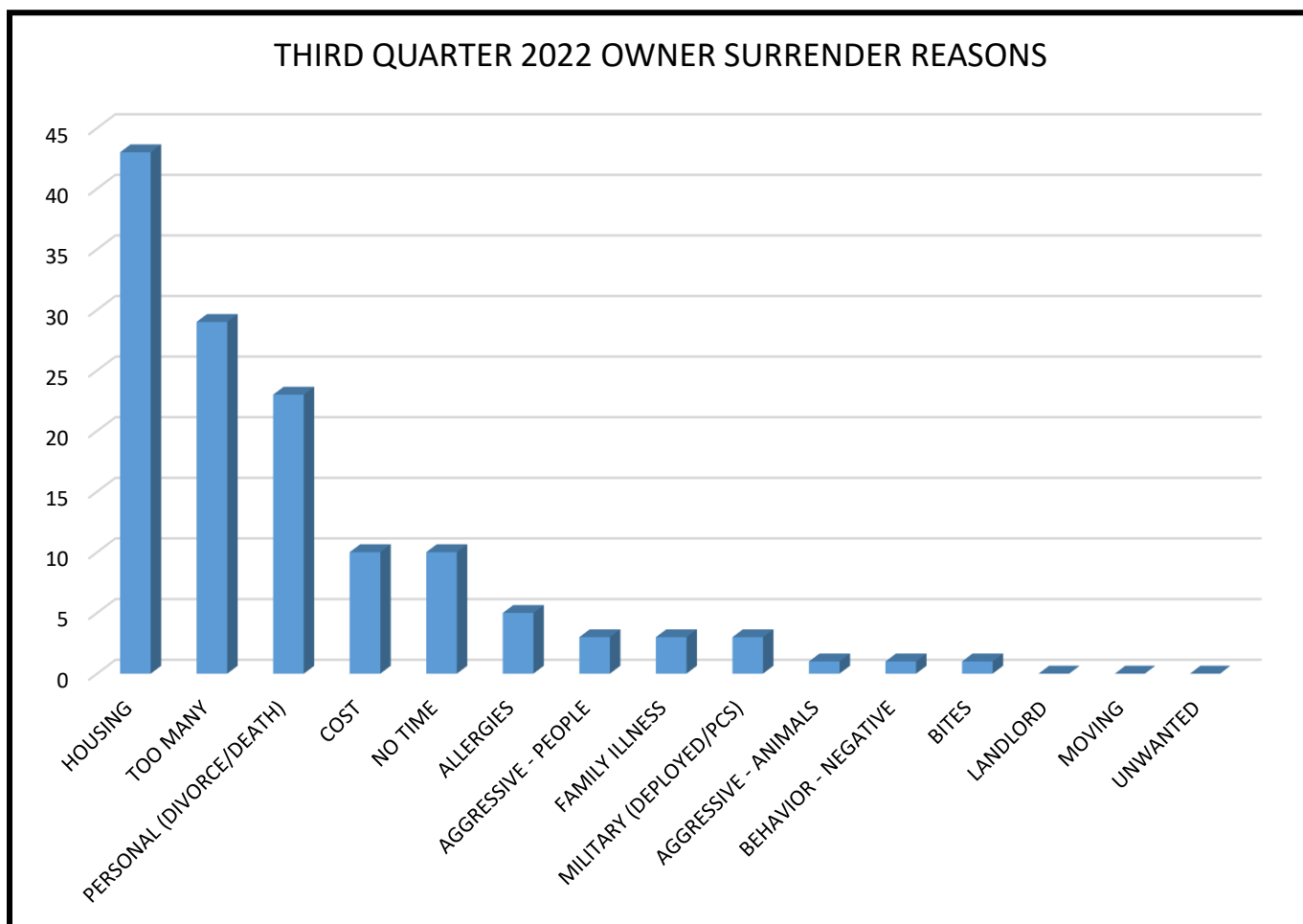
The shelter took in 1,276 animals in the Third Quarter of 2022. A majority of those intakes, (86%) were stray animals either picked up in the field or brought in over the counter. (12%) were owner surrendered pets and the remaining (2%) consisted of Adoption Returns, Feral Animals, Euthanasia Requests, Bite Quarantines, Protective Custody, and Abandoned Animals.

Owner Surrenders

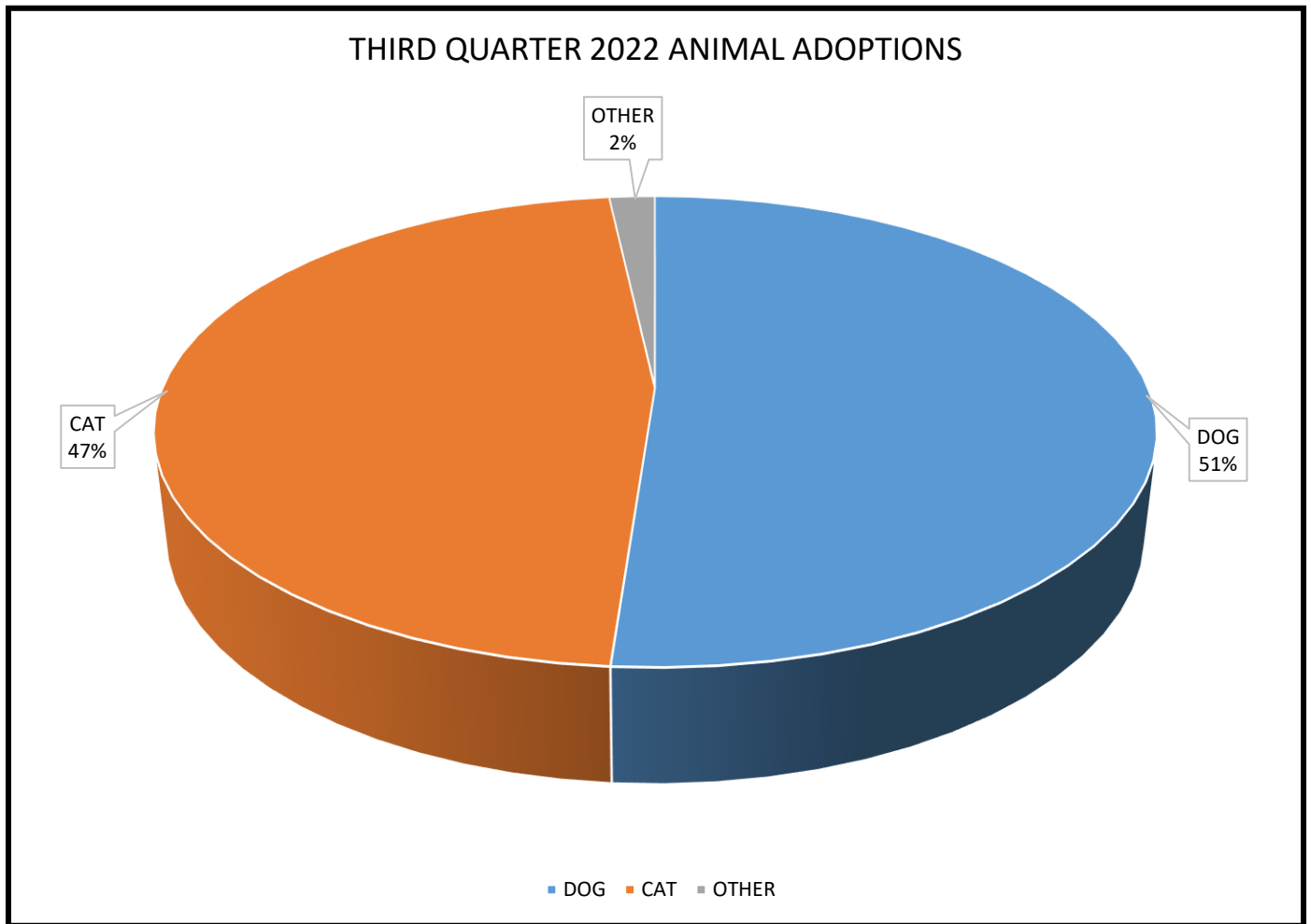
The Third Quarter of 2022 saw a slight decrease in Owner Surrenders. We did see a great increase in surrenders due to housing related issues, which is continuing to trend upwards. The top 4 Reasons for surrender were related to having Housing – 33% (35% increase over Quarter 3 2021), Too Many Pets – 22%, Personal Reasons – 17% and Cost – 7%

Adoptions

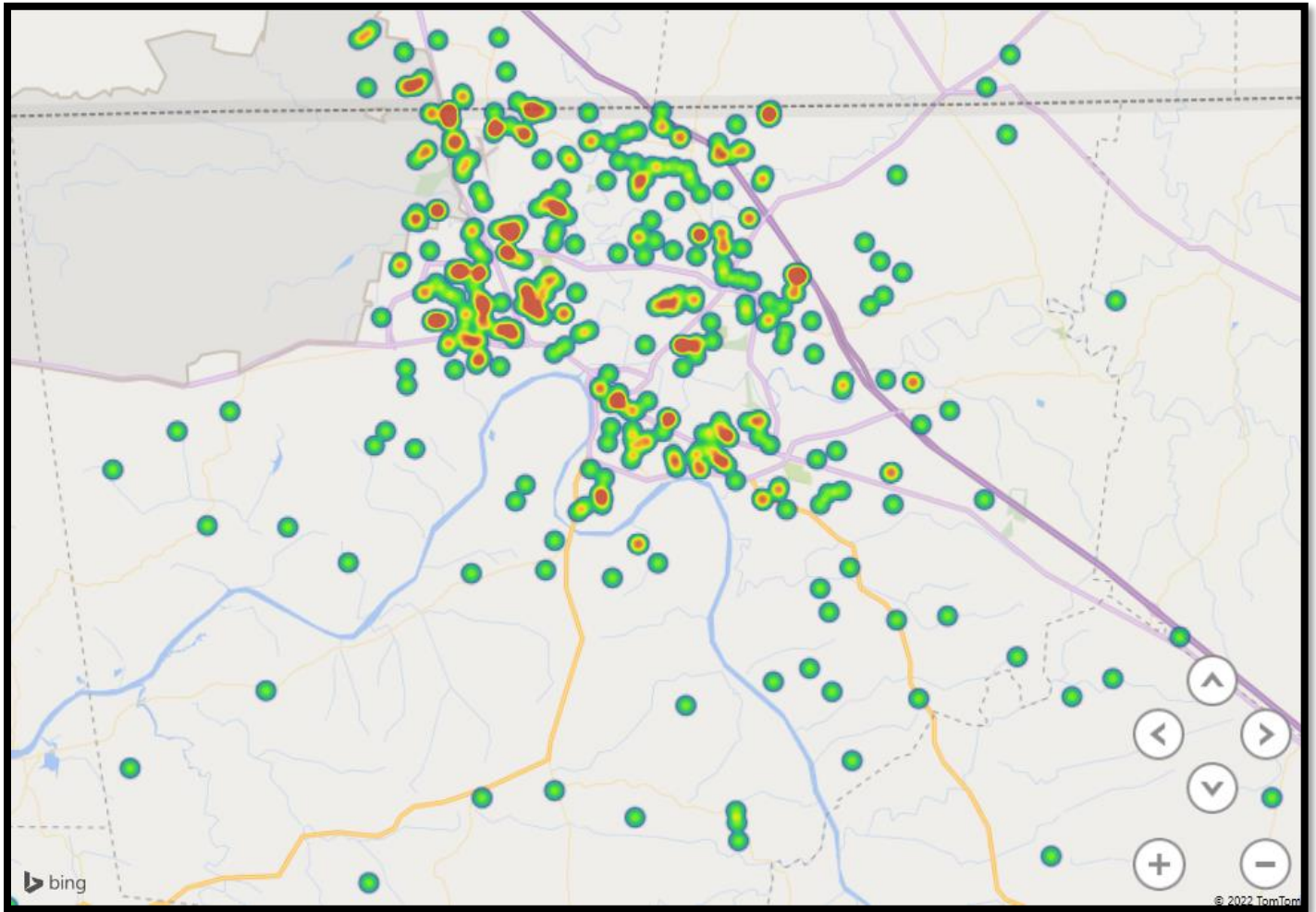

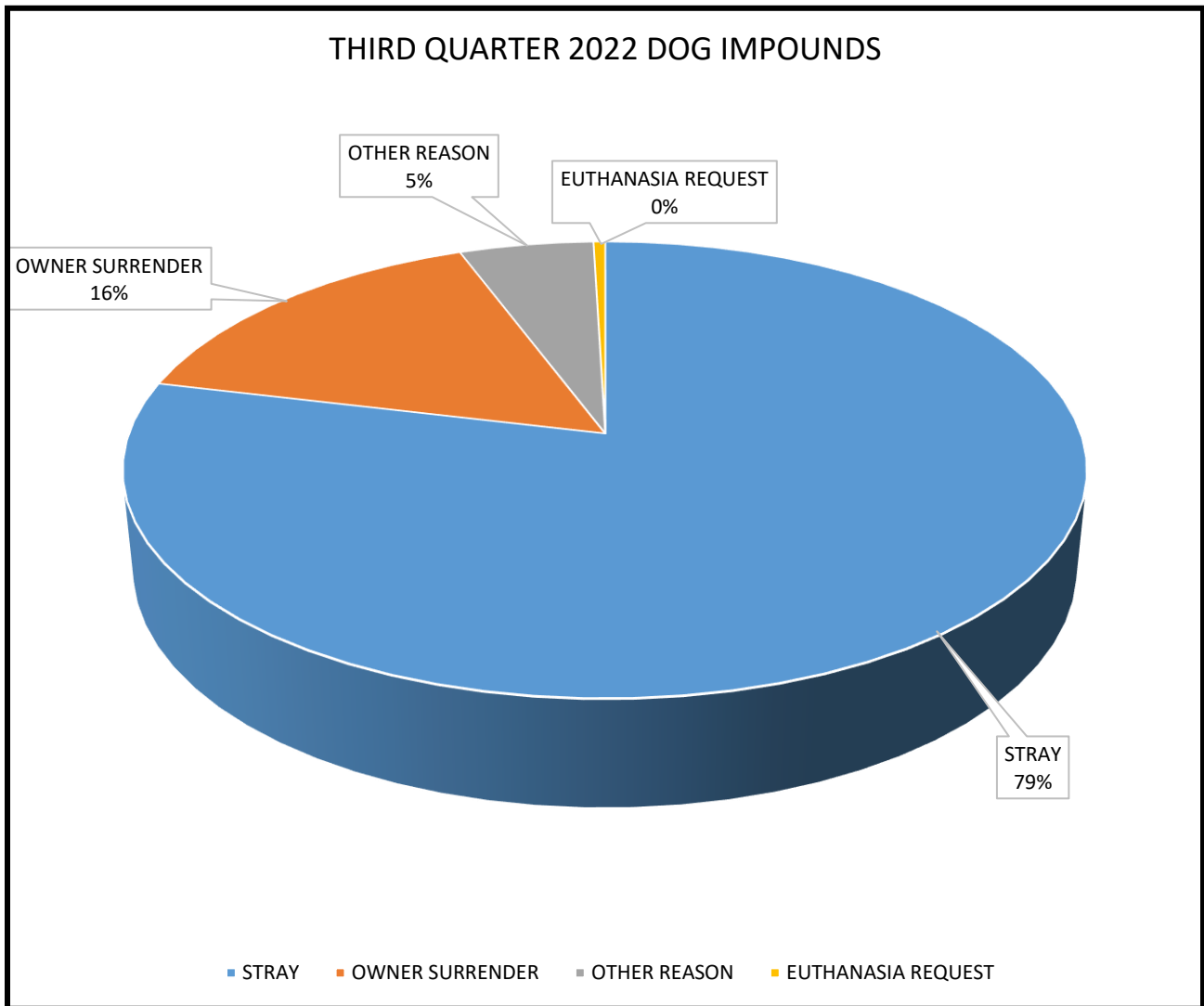
Adoptions Heat Map

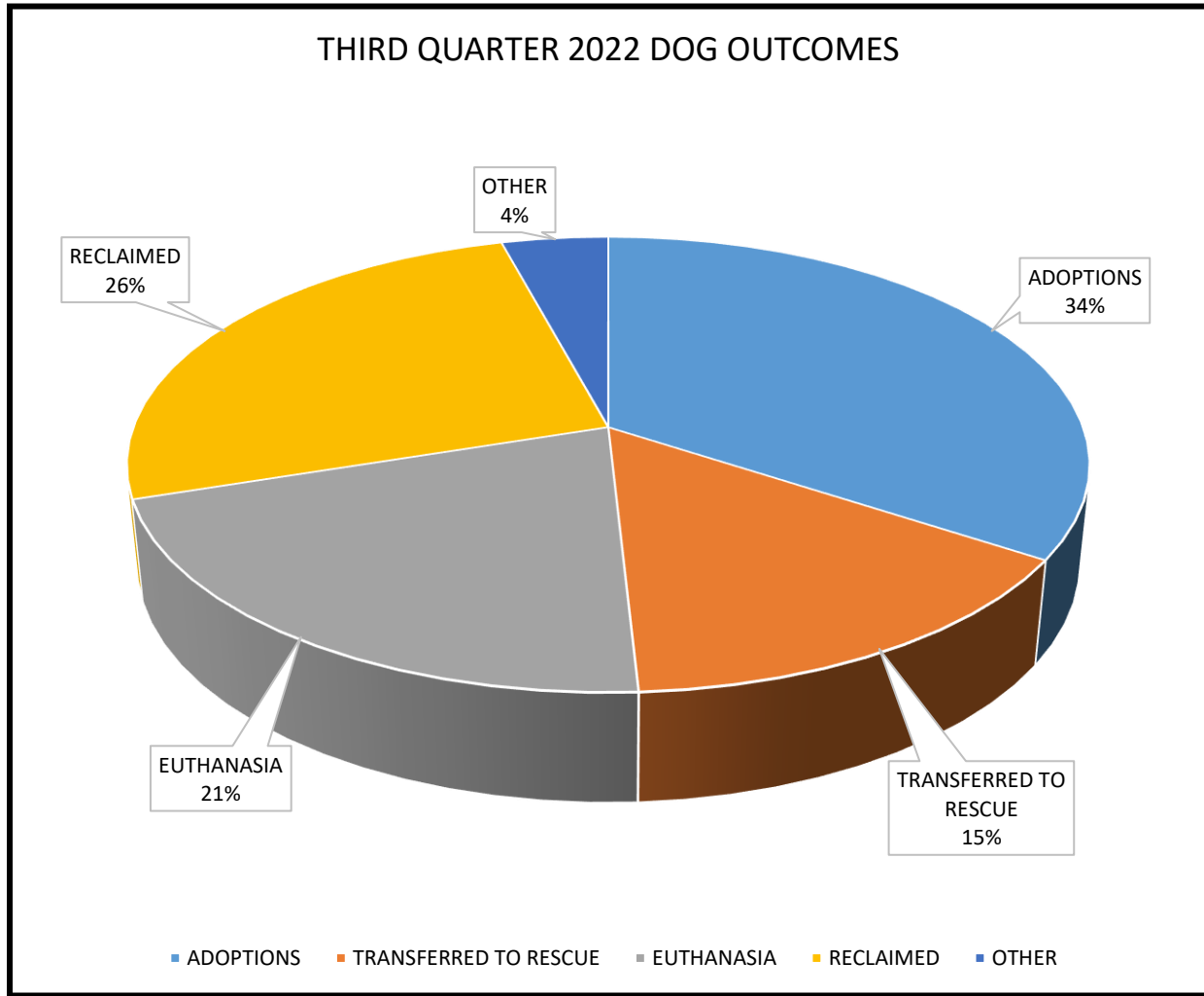

Dog Outcomes

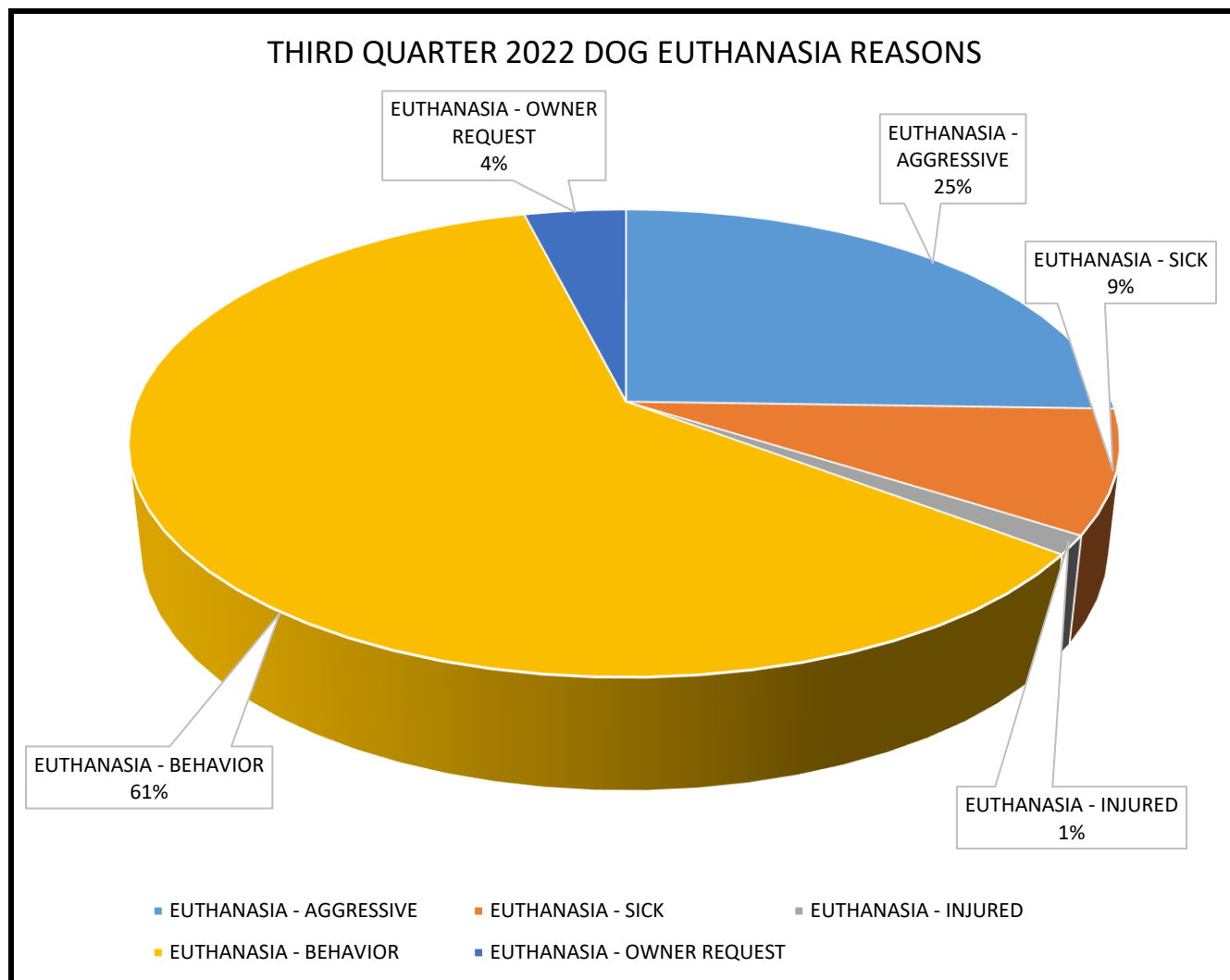
763 Dogs left the shelter in the Third Quarter of 2022. Outcome reasons were Reclaims at 26%, Adoptions 34%, and Euthanasia 21%. Another 15% were sent or transferred to rescues, Humane Association, or other shelters for adoption.

Dog Euthanasia

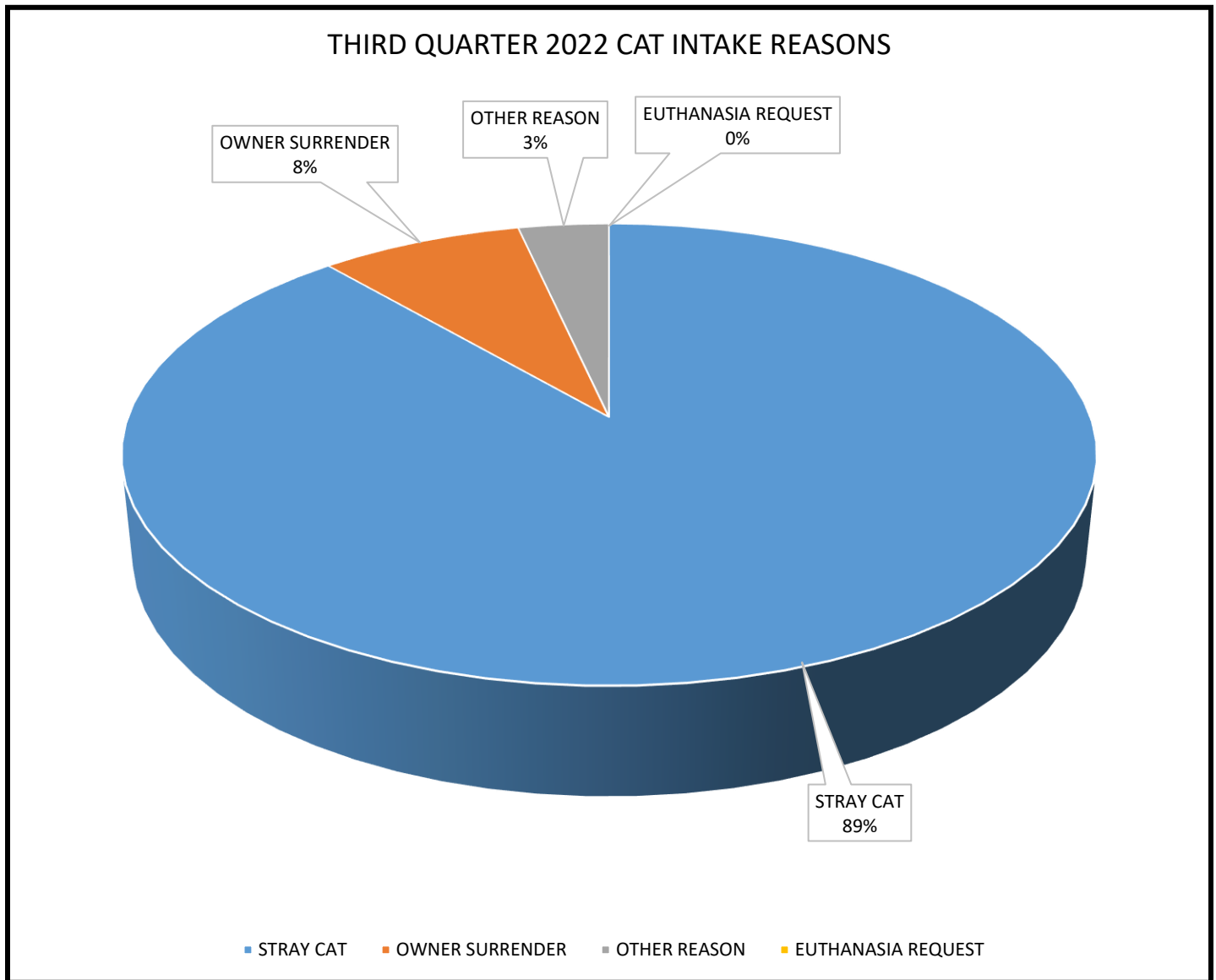
Of the 158 dogs euthanized, 86% were for behavior or aggression problems that were deemed unadoptable or rescue candidates. Those problems were identified through owner reports, staff experience and interaction with the dog, shelter temperament testing, and previous bite or aggression history. Other dogs were euthanized for medical issues 10%, space due to overcrowding and no available rescues or facilities to accept overflow 0% and owner requested euthanasia 4%

Cats

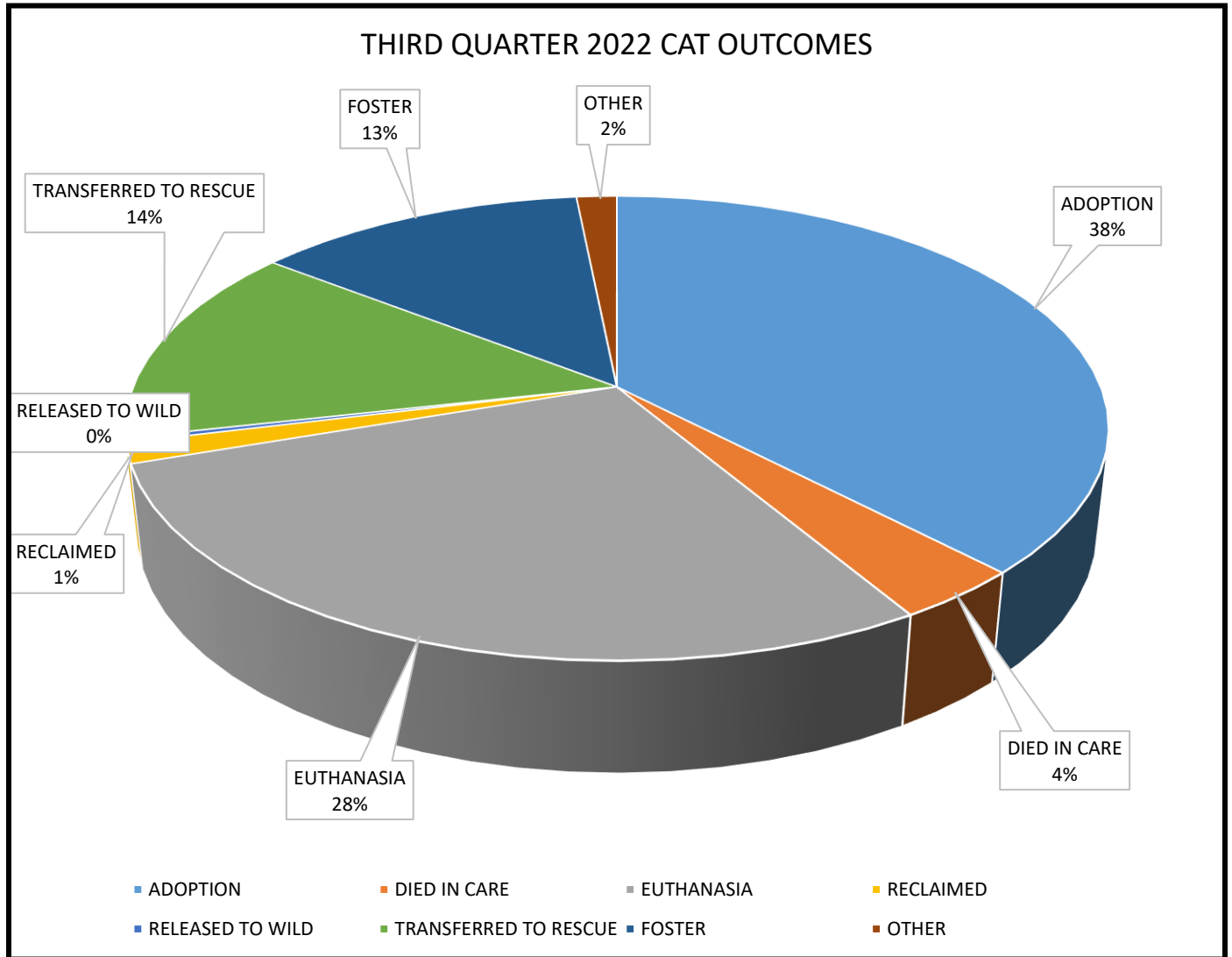
There were 598 cats impounded in Third Quarter of 2022, 89% were strays, 8% were owner releases, and 3% were for other reasons (protective care, bite quarantine, welfare, feral).

Cat Outcomes

Outcomes for cats impounded at the shelter were primarily for Adoptions and Transferred to other shelters, rescues or Humane Societies for adoption 65%. 28% of all cats that entered the shelter were euthanized.

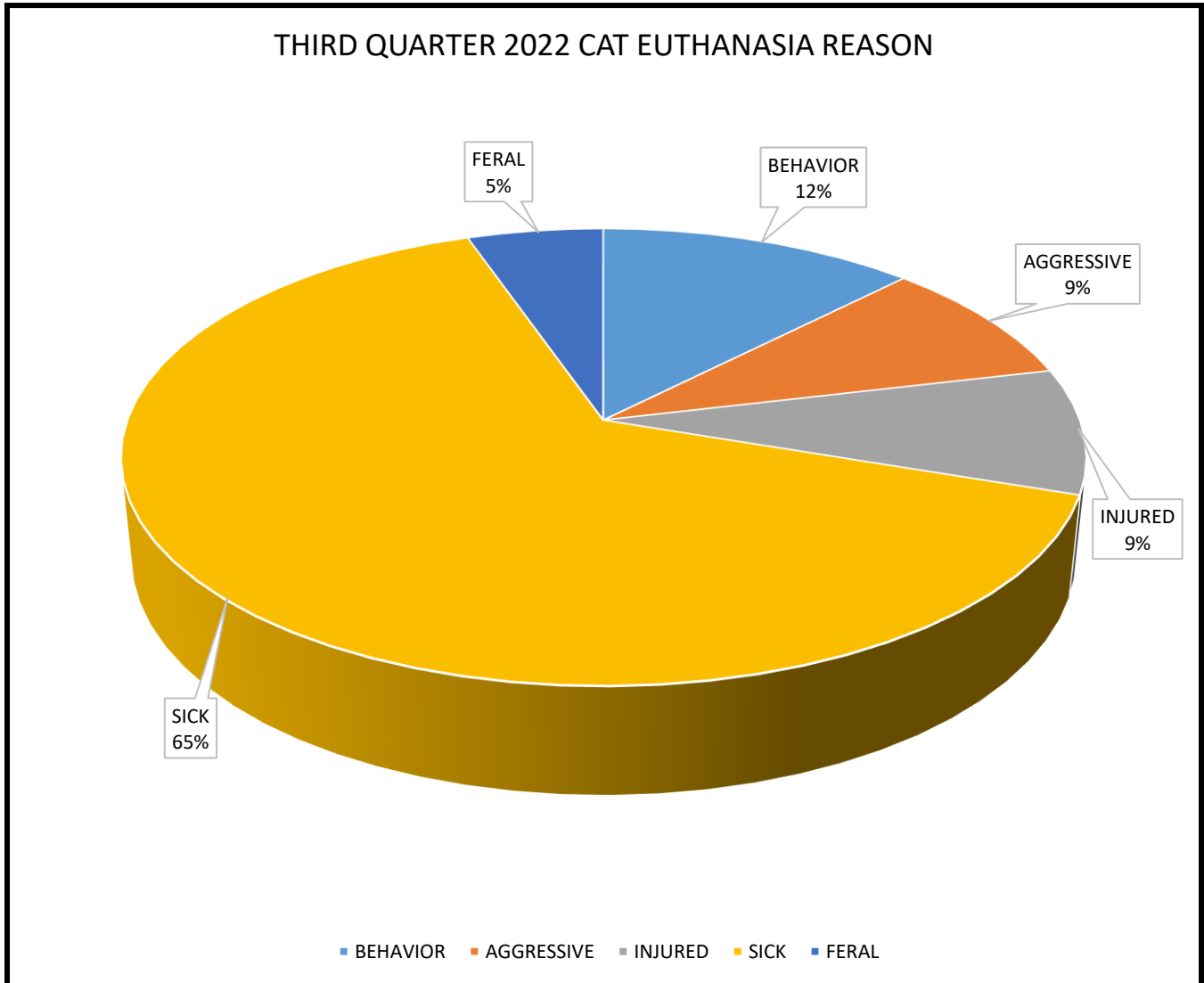

Cat Euthanasia

169 cats were euthanized in the Third Quarter of 2022. We saw a 68% increase from the First Quarter of 2022 primarily due to an unusually high impound rate from a kitten season, extremely ill cats entering the shelter from the community and a large cat impound due to an animal cruelty case in early Spring. 74% of the cats were euthanized for medical reasons, primarily, infectious diseases and injuries, 21% were euthanized for behavioral or temperament problems 0% were Owner requested euthanasia.

NOTE: Due to lack of spaying and neutering we saw a tremendous increase in primarily kittens impounded. A great number of these kittens had advanced Upper Respiratory Infection, emaciated, and other illnesses
