INTRODUCTION

The John T. Cunningham Papers Collection was donated by Howard Winn. The collection contains 1 box of approximately 300 items pertaining to the personal and professional affairs of Judge John T. Cunningham primarily during the 1930s. Access to this collection may be permitted for the purposes of personal and scholarly research. SCOPE AND CONTENT NOTE

In 2010, Howard Winn donated this collection to the Montgomery County Archives. This collection includes personal, business, and political correspondence of John T. Cunningham dating from 1914 to 1944. Letters, notes, and telegrams comprise the bulk of these papers. Checks, bills of sale, financial statements, and a political posters are also part of this collection.

John Talley Cunningham was a prominent judge in Montgomery County, Tennessee in the early twentieth century. An 1899 graduate of Vanderbilt Law School in Nashville, John T. Cunningham (as he was known) served as Speaker of the Tennessee House of Representatives from 1907-1909. Following his time in the House of Representatives, Cunningham made his home in Clarksville and practiced law. Cunningham also operated Minglewood, his farm, and helped found the Eastern Dark-Fired Tobacco Growers Association. In addition to his work in the court system, Cunningham cultivated approximately 20 acres of strawberries and other berries that he shipped via train to the Joseph Denunzio Fruit Company in Louisville, Kentucky. He also sold hay and straw to the military in the late 1930s. Cunningham had political connections in Washington, DC that he used to find government positions for family friends during the Great Depression. Personal correspondence with his Uncle Newell and Uncle Hugh show Cunningham looking after their financial affairs.

The John T. Cunningham Papers Collection is arranged based on type of correspondence and chronological order. Non-correspondence materials are arranged together. During the processing of this collection, paper clips and staples were removed from papers. A number of typed documents were in such brittle, fragile condition to warrant being copied onto acid-free paper. These originals were removed from the collection.
