**ORDER PROBATING SENTENCE
(DOMESTIC VIOLENCE CASES ONLY)**

The defendant is hereby enjoined from committing or threatening to commit acts of violence against the victim, _____ or other household members. ___ The Defendant is ordered to refrain from stalking _____ or any other individual.

___ The Defendant is required to wear an ankle bracelet system, similar to Accutrak, to enforce the above condition(s), specifically, _____

___ The Defendant is hereby ordered to enter and successfully complete a batterer's intervention program, to-wit: _____

___ The Defendant is hereby ordered to enter and successfully complete an anger management program, to-wit: _____

___ The Defendant is hereby ordered to enter and successfully complete an alcohol abuse treatment program, to-wit: _____

_____ The Defendant is prohibited from possessing or consuming alcohol or any schedule or legend drugs, unless in possession of a valid prescription.

_____ The Defendant is hereby ordered not to use or possess any firearm. Further, he/she is also ordered to surrender any firearm currently possessed, to the arresting law enforcement agency during the entire period of probation/diversion.

_____ The Defendant is hereby ordered to undergo outpatient medical or psychiatric treatment, specifically _____ until release is recommended by competent medical or psychiatric authorities.

_____ The Defendant is hereby ordered to enter and remain in the following inpatient medical or psychiatric institution _____ by voluntary self-admission to said institution pursuant to TCA §33-6-201, and to remain therein until release is recommended by medical or psychiatric authorities.

_____ The Defendant is to make restitution payable to _____ in the amount of \$_____ at the rate of \$_____ per month, to begin on _____. Restitution is to be paid through _____.
