BUSINESS LICENSE INFORMATION

- ➤ New business license applications are filed with the Montgomery County Clerk's Office for a fee of \$15.00. You are required to obtain a business license if you anticipate your annual gross receipts to be \$3,000 or more. Additional information regarding exempt businesses is contained in TCA § 67-4-708.
- ➤ There are two types of business licenses available:
 - \$3,000 \$9,999: Minimal Activity License The license is \$15 annually and can be obtained through the local county clerk's office. A Minimal Activity License does not require a tax return to be filed. A new license must be issued annually based on the fiscal year of the business.
 - **\$10,000 and over: Standard Business License** required and taxes remitted electronically.

NOTE: A standard license may be obtained by request for any business regardless of gross income

➤ If a standard business license is obtained, you are taxed on a percentage of your annual gross receipts to renew each year. All returns must be electronically filed and payments remitted electronically to the Department of Revenue on their website at www.tn.gov/revenue. IMPORTANT: By law, all taxpayers must create an account with the State of Tennessee, Department of Revenue, prior to filing a Business Tax return electronically at https://apps.tn.gov/paams. It is critical that you do this as soon as possible and do not wait until the due date of your return, as this could delay processing. Figure 1 If you close your business and have obtained a STANDARD BUSINESS LICENSE, you must:

- 1. Submit a final return and payment of taxes to the Tennessee Department of Revenue within 15 days of selling or closing the business. <u>Simply not renewing will not close your business license and you may be subject to taxes and late fees for the years it was not officially closed</u>.
- 2. Notify the Montgomery County Assessor of Property at (931) 648-5709 to inform them that your business is closed.
- 3. Pay your county personal property taxes at the Montgomery County Trustee's office, (931) 648-5717 and any city taxes at the City of Clarksville, Finance and Revenue Department, (931) 645-7436.
- If you close your business and obtained a MINIMAL ACTIVITY LICENSE, you simply let the license expire. There is no need to contact us or file a return with the state.

If you need to make changes to your business license account (change of address or business name change, etc.):

1. You must contact the Montgomery County Clerk to complete a business license change form or download from our website. If you need a new license to reflect the change, there is a \$5.00 fee.

If there is a change of ownership and/or your federal tax ID # or sales tax number has changed for your standard business license:

- 1. The current owner must submit a final return to the Tennessee Department of Revenue.
- 2. The new owner should apply for a license in their name. If the business is a partnership and you want to remove a partner's name, that person must sign the final return. TCA § 67-4-721 has obligations for the successor business owner in regards to liability of taxes, interest and penalties of the former owner. The new business owner should read TCA § 67-4-721 in its entirety.
