

ADVERTISEMENT FOR BIDS

Sealed bids for the Montgomery County Animal Shelter – Artificial Turf Yards located at 435 Jordan Road, Clarksville, TN will be received by Elizabeth L. Black Purchasing Agent, Montgomery County Purchasing at 350 Pageant Lane, Suite 101-E, Clarksville, TN 37040 until 2:00 P.M. on Tuesday, March 11, 2025.

The Scope of Work for this project includes:

Base preparation and install of artificial turf system for outdoor animal exercise yards at the Montgomery County Animal Shelter. Turf area is approximately 10,400 ft². The turf yards are broken up into 14 different sections with varying areas separated by a 1' wide concrete mow strip or border and fencing. The bid will include all labor and material. All products shall be installed per manufacturers recommendations and labor must be warrantied for 1 year.

In order to bid, qualified bidders shall obtain one (1) copy of the bid document files in PDF format prior to or immediately following the mandatory Pre-Bid Conference. Contractors, sub-contractors, and suppliers may obtain a link to the PDF contract documents by requesting them via email from Montgomery County Engineering engineer@mcgtn.net. Upon request, an e-mail response will be sent back within 48 hours with a link to download the project documents. Interested Contractors, sub-contractors and suppliers may purchase full-size paper copies of the bid documents according to the Instructions to Bidders Section 20.

All Bidders must be licensed Contractors in the State of Tennessee in strict accordance with State regulations. No bid will be opened unless the outside of the sealed envelope containing the bid provides the following information: the Contractor's name, address, and license number; the date of the license expiration; and a quotation of that part of the license classification applicable to the bid.

Each Bidder must deposit (with his/her bid) bid security in the amount of five percent (5%) of the amount of the bid and subject to the conditions provided in the Information for Bidders.

No Bidder may withdraw his bid for sixty (60) days following the bid opening.

The right to reject any or all bids and to wave technicalities is reserved by the owner.

A MANDATORY pre-bid meeting will be held at Montgomery County Animal Shelter construction site, 435 Jordan Road, Clarksville, TN 37042 followed by a site walk, on **Tuesday, February 25th at 10:00 AM**. Pre-bid meeting will be held in conference room portion of the Future Animal Shelter building that is on the west end of the site.
