(4) **RESPONSIBLE VENDORS-** Failure of a vendor to execute a purchase order awarded to him or to comply with any of the terms and conditions therein may disqualify him from receiving future business.

(5) PROPOSING FIRM- The agent of the proposing firm hereby certifies to the best of his knowledge and belief that this bid/proposal submitted to Montgomery County has not been prepared in collusion with any other seller of similar products. The Clarksville-Montgomery County Highway Department is looking to purchase a new Oil Distributor. Minimum specifications are provided for both chassis and oil distributer unit.

2. <u>TIMELINE:</u>

Answers Provided – Thursday, December 12, 2024 RFP Deadline – Tuesday, December 17, 2024 at 10 a.m. CST

Bids submitted after the deadline will not be opened. Bids must be sealed and may be mailed or hand delivered to the Montgomery County Purchasing Department, 350 Pageant Lane, Suite 101-E, Clarksville, TN 37040. All bids should include all necessary documents and have the name of the proposer and the words "Bid – Highway Dept Oil Distributor" on the outside of the envelope. Proposals may also be submitted by email and can be sent to mocobids@mcgtn.net. If submitting by email, allow plenty of time for delivery as proposals must be <u>received</u> by the deadline. Make sure to put "Bid – Highway Dept Oil Distributor" in the subject of the email.

Vendors must guarantee that all information included in the bid will remain valid for a period of at least 90 days from the date of the bid/proposal opening to allow for evaluation of all bids. Bids/proposals may be withdrawn at any time up until the time of opening. A withdrawn bid/proposal may be resubmitted up to the time designated for the receipt of bid/proposals provided it fully conforms to the same general terms and requirements.
