<u>Section 4. A.</u> Mapping is done as time and personnel resources allow. The process also depends on "as-built" plans submitted by development engineers.

Outfalls are visually screened during routine area visits conducted for other purpose (complaint investigations, etc.)

<u>Section 6. H.</u> There are no public Stormwater Control Measures within the Montgomery County jurisdiction. The Stormwater Maintence Agreement required by Sections 5 and 6 of the Montgomery County Stormwater Regulations (Resolution 13-2-2) obligates SCM landowners to inspect and maintain all SCMs and convayance structures.

<u>Section 7.B.</u> Not all departments have had the Good Housekeeping training this permit cycle. This is an ongoing process and will continue throughout the permit cycle.
